### **State of the Organization**

As of today we have 120 members. As a board we want to be transparent and have open communication with the pickleball community and its members. George to post the minutes on the website.

### **Ladder Play Update**

The ladies ladder play has been a success! We had 16 women sign up to participate for 6 consecutive weeks of play. Two of the dates were rained out but Parks and Recreation has credited our account in the amount of \$20. It was decided amongst Lisa and myself that the rating system could be streamlined if we had the highest player of each court move up and the lowest player move down. In effect each player is playing to get to the next level court or at least maintaining their position at their current court. The current ranking system created by Lisa was complicated for open play but could be used for closed play (set group of individuals) Lisa had spoken to a person well versed with the excel program and was told that trying to rank individuals within a certain time frame was not possible. Using the new system for a closed ladder play is much easier and anyone can learn the system.

Annie Powers was our winner with the most wins at court 1. The feedback from all the ladies was positive and each one would like to continue the ladder.

We will be having a meeting on November 29th to plan out an annual calendar for the year 2023 to include all events put on by SOPA including the tournaments, clinics and social events.
